



**2019-2020 KINDERGARTEN REGISTRATION**  
**Tuesday, February 19, and Wednesday, February 20, 2019**

Rogers Public Schools kindergarten registration for the 2019-2020 school year will be **Tuesday, February 19<sup>th</sup>, from 9 a.m. until 6 p.m. and Wednesday, February 20<sup>th</sup> from 9 a.m. until 4 p.m.**

**A child must be 5 years old on or before August 1, 2019, to enroll.** Online registration is now available at <https://registration.rpsar.net>. Enrollment is not complete until you come to the school on registration day and bring the following documents:

- ❖ One of the following identification items: a copy of the child’s Birth Certificate; hospital record; an attested baptism certificate; a passport; a statement by the local registrar or county recorder; an affidavit of the date and place of birth by the child’s parents or guardian or a United States military identification.
- ❖ An identification number for the student (A Social Security number or request that the school assign a number.)
- ❖ Completed Immunization Record including 4 doses of Diptheria, Tetanus, Pertussis with 1 dose on or after the 4<sup>th</sup> birthday, 3 or 4 doses of Polio with 1 dose on or after the 4<sup>th</sup> birthday, 2 doses MMR (measles, mumps, rubella) with dose 1 on or after the first birthday, 3 doses of Hepatitis B, 1 dose of Hepatitis A on or after the 1<sup>st</sup> birthday and 2 doses of Varicella (chickenpox) with dose 1 on or after the 1<sup>st</sup> birthday and dose 2 at least 28 days after dose 1. A medical professional’s (MD,APN,DO,PA) history of disease in writing may be accepted in lieu of receiving Varicella vaccine.
- ❖ Proof of address within the district boundaries, which may be verified with one of the following sets of documents:
  1. A current real-estate property tax receipt and a current utility bill showing the name and address of the student’s parent or legal guardian.
  2. A rental or lease agreement and a current utility bill showing the name and address of the student’s parent or legal guardian.
  3. Copies of a current utility bill from two different utility companies showing the name and address of the parent or legal guardian.

If all the necessary proof of address documents are not provided, parents will be asked to bring the documents they have to the district administrative office to sign an affidavit.

- ❖ Current proof of a physical examination within the past 24 months or within 90 days after the student’s initial enrollment in kindergarten. This exam is required by the State.

Registration will be conducted at all district elementary schools. Students will register at their attendance boundary school. Fairview Elementary will be opening in the fall of 2019. Boundary students for this school may register at Janie Darr Elementary or Elza Tucker Elementary.

**Children should attend registration with their parents.** The children will be screened for kindergarten readiness as part of the registration process.
